During the 2022-2023 fiscal year, Bo's Place clinicians provided support, resources, and referrals to 4,101 individuals seeking help or resources through the information and referral line. Bo's Place enrolled 1,452 individuals in online and in-person grief support groups (611 children and 841 adults) who collectively attended 8,961 service sessions. Bo's Place clinicians and staff provided 24 community education and training workshops throughout the greater Houston area to various audiences, including professionals in the social service, medical, educational, and faith-based communities (reaching 1,239 individuals).

Bo's Place offers programs in English and Spanish at no cost to the bereaved.

This process is conducted on an annual basis.
