During the 2023-2024 fiscal year, Bo's Place clinicians provided support, resources, and referrals to 3,435 individuals seeking help or resources through the information and referral line. Bo's Place enrolled 1,251 individuals in online and in-person grief support groups (522 children and 729 adults) who attended 7,978 service sessions. Bo's Place clinicians and staff provided 40 community education and training workshops throughout the greater Houston area to various audiences, including professionals in the social service, medical, educational, and faith-based communities (reaching 1,083 individuals).

Bo's Place offers programs in English and Spanish at no cost to the bereaved.
